Government Code section 11125.7 provides the opportunity for the public to address each agenda item during discussion or consideration by the working group prior to the group taking any action on said item. Members of the public will be provided appropriate opportunities to comment on any issue before the working group, but the chair may, at his or her discretion, apportion available time among those who wish to speak. Individuals may appear before the working group to discuss items not on the agenda; however, the working group can neither discuss nor take official action on these items at the time of the same meeting [Government Code sections 11125 and 11125.7(a)].

The meeting is accessible to the physically disabled.
