




## **Business and Professions Code Section** 5600.05

Requires architects to complete five (5) hours of CE on Zero Net Carbon Design (ZNCD), in addition to five (5) hours of CE on Disability Access requirements (ADA), for a total of 10 CE hours; as a condition of license renewal.

- •In person/Live Webinar Course
- •70% minimum score
- Architect, Professional, Civil, Mechanical,
   Structural Engineer (3yrs)
- •International Code Council (ICC) National Certification
