California Architects Board Welcomes New Board Member

Amanda Steidlmayer, of Woodland, was appointed to the Board on May 22, 2025. License Renewals

On January 1, 2025, the California Architects Board (CAB) transitioned license renewals to its online application portal, **Connect**. Licensees who were issued an architect license prior to June 1, 2023, or those who submitted a paper license application afterward must first register a Connect account and then subsequently link their architect license to the account.

Architects who submitted an online license application after June 1, 2023, have already registered a Connect account they may use to renew their license. This is because the license is already linked to the Connect account.

Licensees are ineligible to renew online if their license has been delinquent for more than one renewal cycle (two or more years) and must **[contact CAB](#)** for assistance.

Architects who are eligible to renew online and did not submit an online initial (or original) license application must register a Connect account and link their license.

Register a Connect Account

Register a Connect account by selecting the "Click here to Register" link located directly below the "Log In" button (see below). This will start the process for creating a Connect profile.

It is important that an architect verify all the personal information in their profile, such as the email address, name, date of birth, and the last four digits of the Social Security Number, is correctly entered during account registration process. Incorrect personal information entered when registering the account will cause errors when an architect attempts to link and renew their license. These errors must be corrected by CAB and may cause delays with the license renewal process that could potentially result in license expiration and a delinquency fee.

Renewal Process

Architects start the renewal process by logging into their Connect account and entering the email address used to register the account in the “User Name (Email)” field. There will be a prompt to change the temporary password if this is the first time logging into Connect.

Next, an architect must link their existing architect license to their Connect account by clicking the green “License Link” button located above the Actions column of the Licenses block of the dashboard (see below).

After clicking the “License Link” button, a new input window will appear from which an architect must select the license type from the dropdown list and then enter their license number **omitting the preceding “C.”** Then click “Submit.” If an error message is received, please contact CAB via email at cab-connect@dca.ca.gov. Please be sure to include your full name, license number, and a screenshot of the error in the email.

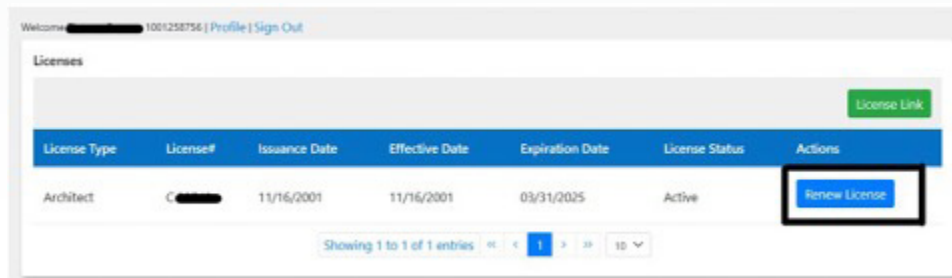

An architect's license information should now appear in the Licenses block on the user dashboard. If an architect is **within 90 days of their license expiration date**, the option to "Renew License" should be available under the "Actions" column. Select this option to be directed to the renewal application.



The renewal application consists of several tabs located on the lefthand side of the window. The tabs are:

- Instructions and Disclosures
- Personal Information
- Renewal Questions
- Attestation
- Fee and Payment

Complete each application tab, **making sure to select the option to "Save and Continue" at the bottom of each application tab**. You will be automatically directed to the next application tab, and the previous tab should now display a green check mark indicating it is completed.

Architects on the "Renewal Questions" tab of the application must certify completion of the mandatory 10 hours of continuing education (CE) and can upload their documentation verifying completion. The mandatory CE consists of five hours on disability access requirements (ADA) and another five hours on zero net carbon design (ZNCD) as required per **BPC Section 5600.05** and California Code of Regulations sections **165** and **166**.

The checkbox next to the declaration on the Attestation tab must be checked and then the **full legal name** must be typed in the "Signature" field. The signature date cannot be edited and is set to the date you are completing the application. Select "Save and Continue."

The final step in the process is completion of the "Fee and Payment" tab. On this tab, an architect will enter the information for their preferred payment card (**we only accept Visa, Mastercard, or Discover**) and enter their billing information. Select the option to "Copy Details from Application" if the billing information is the same as the address on the application. The billing address does not need to match an address of record. The button to "Pay and Submit" should now be green and selectable.

Click the option to "Pay and Submit." **Make certain to only click the button one time and do not refresh the page.** Otherwise, there may be duplicate payments. The application status for the renewal application in the Applications block of the dashboard should say "Approved," and the license information in the Licenses block of the dashboard will now reflect an updated expiration date (see below). An architect will also receive an email and/or text notification that the license has been successfully renewed.

The renewal process is then complete, and an architect can then exit from Connect.

RENEWAL NOTIFICATIONS

Starting July 1, 2025, CAB began sending renewal notices to licensees in the form of a notification postcard. Previously, CAB would mail licensees a renewal notification that included a remittance form for payment. The renewal postcard directs architects to renew their license using the online application portal, **Connect**. The postcards are mailed approximately 90 days prior to the license expiration date.

The switch to a postcard notification format greatly reduces our carbon footprint related to license renewals. It also affords more payment options. CAB always strives to improve operational efficiency and reduce its impact upon the environment.

Regulations Affecting Licensure

Eligibility for Examination—Changes approved by the National Council of Architectural Registration Boards (NCARB) in 2024 allowed licensure candidates to take the Architect Registration Examination (ARE) after applying with NCARB as well as registering to complete the Architectural Experience Program (AXP), and removed the experience requirement to begin testing. After discussion, the Board also agreed to remove the experience requirement to take the California Supplemental Examination (CSE).

This proposal removes the experience requirement to take the ARE and CSE, removes the requirement that the CSE is only available after a candidate has taken and passed the ARE. However, candidates are still required to apply with the Board and establish an NCARB record before being eligible to take either examination.

This proposal was approved and will go into effect on October 1, 2025.

Reasonable Accommodation—Staff identified that the Board's requirements for CSE reasonable accommodations requests were not clearly defined in regulation. This caused confusion on what candidates needed to provide to the Board to receive accommodations.

This proposal codifies the method by which candidates request reasonable accommodations, and the documentation required to substantiate those requests.

This proposal was approved and will go into effect on October 1, 2025.

License Certification Fee—At its February 22, 2024 meeting, the Board reviewed a budgetary analysis of its fund condition and fee analysis related to license certifications completed by staff. Due to the staff impact when completing the volume of certifications received and the associated workload, the Board proposed adding the authority to charge a fee as part of its sunset bill, which was passed and authorized on January 1, 2025. Therefore, the Board created a regulation to specify the fee.

This proposal sets the fee for a license certification at \$40.

This proposal was approved and went into effect on October 1, 2025.



Enforcement Actions

January 2025–March 2025

Final Citations

FLORENCIO GONZALO LUNA HERNANDEZ

(San Bernardino)—The Board issued a one-count citation with a \$2,000 administrative fine to Florencio Gonzalo Luna Hernandez, an unlicensed person, dba Drafting and Design Services, for alleged violations of Business and Professions Code sections 5536(a) and California Code of Regulations section 134(a).

On or about July 22, 2024, the Board received a complaint alleging possible violations of the Architects Practice Act regarding two residential projects located in Jurupa Valley. After meeting at the San Bernardino Planning Department, Luna Hernandez signed a contract with Ms. D.E. (client) to draft blueprints for two doorways for the Emerald Drive residence for a fee of \$750, and a “main house legal room addition and bathroom addition. ADU garage with bedroom, bathroom, kitchen and dining room” for the Valley Project. Luna Hernandez has been paid a total of \$6,480, but never completed the projects and stopped responding to his client’s calls.

Luna Hernandez’s personal LinkedIn profile used the title of “Senior Architect” and offered “architectural” services. His company Yelp profile was categorized under “Architects.”

The Board mailed letters to the address on the written contract on September 18, 2024 and October 17, 2024. Luna Hernandez failed to respond or make changes to his online content.

Luna Hernandez’s online profiles (LinkedIn/Yelp), wherein he used the title of “Licensed Architect” and “Senior Architect” and described his company as “Architects” and his services as “Architectural,” are devices that might indicate to the public that Luna Hernandez is an architect or qualified to engage in the practice of architecture in California. Such conduct constitutes violations of Business and Professions Code section 5536(a) and California Code of Regulations section 134(a).

ELEMENTS OF AGGRAVATION

On July 15, 2020, the Board issued a two-count citation that included a \$2,000 administrative fine to Florencio Hernandez, dba JH Design & Drafting Services, an unlicensed individual, for alleged violations of Business and Professions Code sections 5536(a) (Practice Without License or Holding Self Out as Architect) and 5536.1(c) (Practicing Architecture).

The 2020 action alleged that Hernandez’s firm, JH Design & Drafting, offered to design an addition to a commercial building in Hemet. In addition, JH Design & Drafting created plans for a second commercial building in San Bernardino. Because offering to design an addition to an existing commercial building and preparing plans for the construction of a new commercial building are not exempt services under Business and Professions Code sections 5537 or 5538, such conduct constituted violations of Business and Professions Code Sections 5536(a) and 5536.1(c). The citation in that case became final on August 14, 2020 and remains unpaid.

The new citation became final on January 18, 2025.

ERIC MARTINEZ-LUCIO (Watsonville)—The Board issued a three-count citation with a \$7,500 administrative fine to Eric Martinez-Lucio, an unlicensed person, dba Urbatect Development, LLC, for alleged violations of Business and Professions Code section 5536(a) and California Code of Regulations section 134(a).

On or about July 15, 2024, the Board received a complaint alleging possible violations of the Architects Practice Act. Martinez-Lucio, doing business as Urbatect Development, LLC, was hired to provide design services for a residential project located in Dillon Beach for Mr. G.M. (client).

Martinez-Lucio’s Design Services Agreement stated Urbatect “shall provide architectural design” for three ground-up homes to include the schematic design, design development and construction documents for a fixed fee of \$30,000. The client alleged that Martinez failed to provide the services agreed to in the contract and delayed the project.

Martinez-Lucio's company Facebook profile stated, "We are a multi-disciplinary design firm specializing in high-end architecture, ADUs, & construction." His company Houzz profile included several non-exempt projects such as the Salvatore Apartments, Tynan Village Apartments, and St. Leo's Apartments. His company Instagram profile offered "Architecture" and includes "#architecturefirm." His company Build Zoom profile offered "Architectural Drawings and Designs" and "Other Architecture and Engineering" services. His Craigslist post offered services that included "Architect," "Architectural Designer," and "Architectural."

Martinez-Lucio's business name, contract, online profiles (Build Zoom, Facebook, Houzz, Instagram) and online Craigslist advertisement, wherein he described his services as "Architecture" and "Architectural" and offered an "Architect" are devices that might indicate to the public that Martinez-Lucio is an architect or qualified to engage in the practice of architecture in California. Such conduct constitutes violations of Business and Professions Code section 5536(a) and Title 16, California Code of Regulations section 134(a). The citation became final on March 22, 2025.

TUAN JONATHAN NGUYEN (Westminster)—The Board issued a one-count citation with a \$2,500 administrative fine to Tuan Jonathan Nguyen, an unlicensed person, dba Do Green, for alleged violations of Business and Professions Code section 5536(a).

In or around February 2023, the Board received a complaint against Nguyen alleging violations of the Architects Practice Act related to offering and providing architectural services without a license.

Nguyen advertised "architectural services" through an online Vietnamese newspaper, Nguoi Viet, despite not being a licensed architect. Mr. C.P. (Client) found the advertisement on Nguoi Viet and contacted Nguyen to design an Accessory Dwelling Unit (ADU) for the Client's property located in Garden Grove. On February 19, 2023, the Client entered a contract with Nguyen, under which Nguyen agreed to provide "architectural services." Nguyen billed the client specifically for "architecture" services and later abandoned the project.

Despite multiple requests from the Board, including correspondence sent on November 29, 2023, and February 9, 2024, Nguyen failed to respond to the Board's inquiries regarding these allegations.

Nguyen was previously cited by the Board for using the term "architectural" in a proposal and in a business name (Citation #2019-23). Additionally, Nguyen's actions in this new case caused consumer harm, evidenced by the client's small claims court judgment against Nguyen and the abandonment of the project.

Nguyen represented himself as an architect through advertising, contract language, and invoicing, in violation of Business and Professions Code section 5536(a). The citation became effective December 6, 2024.

MILAD B. OUEIJAN (Hacienda Heights)—The Board issued a two-count citation with a \$3,000 administrative fine to Milad B. Oueijan, an unlicensed person, dba B Hive Design Group, for alleged violations of Business and Professions Code sections 5536(a) and 5536.1(c).

On or about September 29, 2023, the Board received a complaint alleging Oueijan misrepresented himself as a licensed architect. The complainant, Mr. J.E.M., witnessed Oueijan giving a presentation at a public City Planning Commission meeting in Corona on September 25, 2023, regarding a senior housing development located on North Buena Vista Avenue in Corona. Oueijan introduced himself as the "architect of the project."

Oueijan's recorded presentation, wherein he described himself as an architect is a device that might indicate to the public that Oueijan is licensed or qualified to engage in the practice of architecture in California. Such conduct constitutes a violation of Business and Professions Code section 5536(a).

The plans prepared by Oueijan include a senior housing development consisting of 62 units. This project is not exempt from licensing requirements under Business and Professions Code section 5537. Such conduct constitutes the practice of architecture as defined in Business and Professions Code section 5500.1 and a violation of Business and Professions Code sections 5536(a) and 5536.1(c). The citation became final February 2, 2025.

Final Citations

Arnold, Stephen Mills (San Francisco)—The Board issued a one-count citation that included a \$250 administrative fine to Stephen Mills Arnold, architect license number C-18186, for an alleged violation of Business and Professions Code section 5600.05(a)(1) (License Renewal Process; Conditions; Certifications; Audit; False or Misleading Information; Disciplinary Action; Coursework Regarding Disability Access Requirements; Submission of Letter to Legislature). The action alleged that Arnold certified false or misleading information on their 2023 License Renewal Application. Arnold paid the fine, satisfying the citation. The citation became final on May 8, 2025.

Crilly, Brian Michael (Sacramento)—The Board issued a one-count citation that included a \$1,000 administrative fine to Brian Michael Crilly, architect license number C-32975, for an alleged violation of Business and Professions Code section 5600.05(a)(1) (License Renewal Process; Conditions; Certifications; Audit; False or Misleading Information; Disciplinary Action; Coursework Regarding Disability Access Requirements and Zero Net Carbon Design; Submission of Letter to Legislature). The action alleged that Crilly certified false or misleading information on their 2023 License Renewal Application. Crilly paid the fine, satisfying the citation. The citation became final on May 6, 2025.

Doughty, Gene Richard (Los Osos)—The Board issued a one-count citation that included a \$500 administrative fine to Gene Richard Doughty, architect license number C-18794, for an alleged violation of Business and Professions Code section 5600.05(a)(1) (License Renewal Process; Conditions; Certifications; Audit; False or Misleading Information; Disciplinary Action; Coursework Regarding Zero Net Carbon Design; Submission of Letter to Legislature). The action alleged that Doughty certified false or misleading information on their 2023 License Renewal Application. Doughty paid the fine, satisfying the citation. The citation became final on April 25, 2025.

Dziengel, Ana Luisa (Sherman Oaks)—The Board issued a one-count citation that included a \$1,000 administrative fine to Ana Luisa Dziengel, architect license number C-33335, for an alleged violation of Business and Professions Code section 5600.05(a)(1) (License Renewal Process; Conditions; Certifications; Audit; False or Misleading Information; Disciplinary Action; Coursework Regarding Disability Access and Zero Net Carbon Design; Submission of Letter to Legislature). The action alleged that Dziengel certified false or misleading information on their 2023 License Renewal Application. The citation became final on May 16, 2025.

Fisher, Brian Evan (Daytona Beach, FL)—The Board issued a one-count citation that included a \$500 administrative fine to Brian Evan Fisher, architect license number C-30714, for an alleged violation of Business and Professions Code section 5600.05(a)(1) (License Renewal Process; Conditions; Certifications; Audit; False or Misleading Information; Disciplinary Action; Coursework Regarding Disability Access Requirements; Submission of Letter to Legislature). The action alleged that Fisher certified false or misleading information on their 2023 License Renewal Application. Fisher paid the fine, satisfying the citation. The citation became final on May 23, 2025.

Flies, Alfred Andrew (Murphys)—The Board issued a one-count citation that included a \$250 administrative fine to Alfred Andrew Flies, architect license number C-24821, for an alleged violation of Business and Professions Code section 5600.05(a)(1) (License Renewal Process; Conditions; Certifications; Audit; False or Misleading Information; Disciplinary Action; Coursework Regarding Zero Net Carbon Design; Submission of Letter to Legislature). The action alleged that Flies certified false or misleading information on their 2023 License Renewal Application. Flies paid the fine, satisfying the citation. The citation became final on May 5, 2025.

Fong, Marilyn J. (San Francisco)—The Board issued a one-count citation that included a \$1,000 administrative fine to Marilyn J. Fong, architect license number C-25913, for an alleged violation of Business and Professions Code section 5600.05(a)(1) (License Renewal Process; Conditions; Certifications; Audit; False or Misleading Information; Disciplinary Action; Coursework Regarding Disability Access

Requirements and Zero Net Carbon Design; Submission of Letter to Legislature). The action alleged that Fong certified false or misleading information on their 2023 License Renewal Application. Fong paid the fine, satisfying the citation. The citation became final on June 11, 2025.

Galindo, Eduardo (Peoria, AZ)—The Board issued a one-count citation that included a \$500 administrative fine to Eduardo Galindo, architect license number C-12130, for an alleged violation of Business and Professions Code section 5600.05(a)(1) (License Renewal Process; Conditions; Certifications; Audit; False or Misleading Information; Disciplinary Action; Coursework Regarding Disability Access Requirements; Submission of Letter to Legislature). The action alleged that Galindo certified false or misleading information on their 2023 License Renewal Application. Galindo paid the fine, satisfying the citation. The citation became final on May 2, 2025.

Gochez-Jacobo, Rene E. (San Gabriel)—The Board issued a one-count citation that included a \$1,000 administrative fine to Rene E. Gochez-Jacobo, architect license number C-21075, for an alleged violation of Business and Professions Code section 5600.05(a)(1) (License Renewal Process; Conditions; Certifications; Audit; False or Misleading Information; Disciplinary Action; Coursework Regarding Disability Access Requirements and Zero Net Carbon Design; Submission of Letter to Legislature). The action alleged that Gochez-Jacobo certified false or misleading information on their 2023 License Renewal Application. The citation became final on June 27, 2025.

Jang, Ryan Joshua (San Francisco)—The Board issued a one-count citation that included a \$750 administrative fine to Ryan Joshua Jang, architect license number C-33368, for an alleged violation of Business and Professions Code section 5600.05(a)(1) (License Renewal Process; Conditions; Certifications; Audit; False or Misleading Information; Disciplinary Action; Coursework Regarding Disability Access Requirements and Zero Net Carbon Design; Submission of Letter to Legislature). The action alleged that Jang certified false or misleading information on their 2023 License Renewal Application. Jang paid the fine, satisfying the citation. The citation became final on May 7, 2025.

Menzi, Stefan H. (Oakland)—The Board issued a one-count citation that included a \$500 administrative fine to Stefan H. Menzi, architect license number C-27904, for an alleged violation of Business and Professions Code section 5600.05(a)(1) (License Renewal Process; Conditions; Certifications; Audit; False or Misleading Information;

Disciplinary Action; Coursework Regarding Disability Access Requirements and Zero Net Carbon Design; Submission of Letter to Legislature). The action alleged that Menzi certified false or misleading information on their 2023 License Renewal Application. Menzi paid the fine, satisfying the citation. The citation became final on May 5, 2025.
